Overview – Conditions of use of the Civil Jobs Board

The Civil Jobs Board is an online service used to advertise job vacancies to job seekers. Employers are welcome to advertise positions on this site if they comply with current State and Federal Australian legislation relating to employment.

The Civil Jobs Board is a self-service system where employers can register and upload their own vacancies. Employers wanting to use this service must supply all information requested and satisfactorily complete the online registration before their application to register will be considered by our friendly team at CCF Victoria.

Once employers have submitted a job to be registered, CCF Victoria will endeavour to either approve or decline the application within 2 working days.

Fees and Charges

- To receive FREE Advertisement opportunities, you must be a financial CCF Victoria Member.
- Limits will be set on the FREE number of Civil Job Board applications as per the table of fees.
- Once a member exceeds their allocated number of free Jobs Board applications, each advert will incur a fee of \$150* + GST.
