## GENERAL REQUIREMENTS FOR ELIGIBLE INDIVIDUALS TO PARTICIPATE

- An eligible individual must be an Australian Citizen, New Zealand Citizen or holder of a permanent Visa.
- USI Number, Current Green Medicare Card or other form of citizenship such as Australian Birth Certificate, Current NZ Passport, Current Australian Passport, Australian Citizenship Certificate etc
- Eligible individual has not previously completed the Construction Industry Skill Set they are currently seeking to enrol
- To check your eligibility please visit our website, and proceed with the enrolment process
- These courses are not eligible for refresher programs, but initial placements only
- No apprenticeship programs or traineeship programs can use this as part of their training plan units
- · No other courses other than those listed
- · There is no age limit
- Participation in the Construction Industry Skill Set will not otherwise impact future entitlement to funded training and for future training it will not be taken into account.

#### **GROUP ONSITE TRAINING AVAILABLE**

This Skills First initiative can also be picked up as part of a group onsite training program (eligibility and consent will be required from each participant individually). Other fees and charges for onsite training will be applicable.
