Contractor (Full Membership)

A person or company engaged in the manufacture, sale, or dry hire (without operator) of plant, equipment and materials used by Contractor Members, or are engaged in any undertaking directly related to, or in supply of, services to those Contractor Members.

Private Associate Membership

Applies to a sole trader providing goods/services to the Civil Construction Industry

Stakeholder Associate Membership

Applies to client groups such as Local Government, Water Authorities, etc.
